



# Diverse Collection Support

### **Run Diversity Audit**

- A diversity audit was conducted at the end of 2021 to identity gaps.
- Selectors are using the results to guide purchase decisions.
- Another audit will be done at the end of the year to assess diverse selection.

### **Develop a Deselection Process and Timeline**

- Audit of Automated Carts in February 2022
- Automated processes established with OverDrive to replace titles that are no longer available for purchase
- Review of titles by subject areas to make sure titles remain relevant **Create Diverse Collection Support Toolkit**

- Monthly modules with tools and resources to assist with selecting diverse material.
- Internal activities by project managers to help promote and market diverse materials



# Increase **Buying Pool**

### Support increase in usage

- 2020.

### **Increase by approximately 5%**

(\$66,722) each year for 5 years.

### Allocate no more than 15% of the increase to youth materials

Wisconsin's Digital Library saw a 16% increase in usage from 2019 to

• 2020 also saw a large increase of new users to the Digital Library.

In 2020 the Collection Development Committee recommended to increase the budget by a fixed amount based on a 5% increase

• \$10,000 for youth materials after an in-depth collection analysis.


## **Uphold previous five-year recommendation**

In the Patron Survey, 88% of respondents reported that they will place a holds if a title is not available. 61% they would still place a hold with a wait time of six months or more. The demand for titles is high and

The majority (35%) of patrons noted that they had checked out more than 20 items from Wisconsin's Digital Library whereas the majority (65%) had checked out fewer than 5 physical books from their local

Staff also support an increase. In the Staff Survey, 48.6% responded that the collection budget was too low for demand, 41.8% responded that they didn't know and 0% responded that it was too high.

Increase the Buying Pool by \$66,722, approximately a 5% increase to the base amount, with no increase to the Hold Reduction amount.


